

## **PRIVACY NOTICE TO CUSTOMERS (on personal data protection and processing)**

Pursuant to articles 13-14 of the EU Regulation 2016/679 on personal data protection, the **Customer** has the right to be informed on the purposes and methods of customer data collection and processing.

**PANGBORN EUROPE** (hereinafter the "Company"), with registered office in Caronno Pertusella (VA), via Enrico Fermi, 75 – 21042, wishes to provide you with the following information according to its Privacy Policy and to the contractual agreements.

The personal data provided by you and eventually concerning the personnel assigned to the performance and management of the agreements with the Company, either where such data have been provided by you directly or if obtained by public sources, will be processed and stored by the Company, both in paper and digital archives, in accordance with the EU Regulation 2016/679 and with local laws in force, particularly for applicable data protection methods.

The Company will process the personal data in a manner to guarantee the respect of individual's rights, fundamental freedoms and dignity, according to the principles of fairness, correctness, impartiality, lawfulness and transparency and **exclusively aimed to comply with legal obligations, tax and accounting obligations, insurance obligations, for the registration of customers into the Company's Management System (customers' list); for the administrative management of the contract, including the management of payments and invoices.**

Pursuant to article 6.1 of the Regulation, the Company can process the data without your consent, in addition to judicial matters, also for the below mentioned cases:

- a) the data processing is necessary to the performance of a contract in which the Data Subject is a contractual party or to fulfil pre-contractual activities required by the Data Subject;
- b) the data processing is required to fulfil a legal obligation of the Data Controller
- c) the data processing is required in order to protect the vital interests of the Data Subject or of another individual;
- d) the data processing is required within the execution of a task carried out in the public interest or connected with the exercise of official authority vested in the Data Processing Controller;
- e) the data processing is necessary for the pursuit of a legitimate interest of the Data Controller or of a third Party, provided there are no prevalent interests or rights and no



fundamental freedoms of the Data Subject, which require the personal data protection, particularly if the Data Subject is a minor.

Pursuant to art. 13 of the above EU Regulation, the **Data Controller** (that is to say the natural or legal person or any other entity or association in its role of decision-maker concerning the purposes, the methods and the tools of processing of the personal data) is **PANGBORN EUROPE** with registered office in via Enrico Fermi, 75 – 21042 Caronno Pertusella (VA).

The data will be stored for maximum 15 years after the end of the contractual relationship, without prejudice to different legal obligations.

The data will be processed inside the European Union and may be disclosed to third parties only for the execution of the abovementioned purposes and for the fulfilment of legal, tax or accounting obligations.

Pursuant to articles 15 to 22 of the above-mentioned Regulation, a Data Subject shall have the following rights:

- the right of access to the data
- the right of rectification
- the right to erasure
- the right to restrict processing
- the right to data portability
- the right to object to processing
- the right to be informed about existence of automated decision-making processes concerning individuals, including profiling.
